- a. School Finance Update

- McClelland enrollment remains steady at approx. 644 students. There are plans to increase enrollment next year.
- TSCS Ended Dec with \$2.3M or ~82 days cash on hand
- Initial discussion/analysis of

- Steady inflow of ESSER 3 reimbursements

- E. McKinney shared the school's increased focus on using data in the classroom.
- 85% of HS teachers now have data tracking systems in classrooms to help all stakeholders know how students are growing and improving.
- ASVAB results had 17 seniors to score 31+ which allows them to earn EPSO credit.
- Currently on track to increase the number of College & Career Readiness by more than 30%.
- Improved staff accountability measures with a 42% increase in staff attendance and promptness.
- Began rolling out our SGEs (Summer Growth Experiences) with students exploring options for their experience.
- Planning for the Positive Youth Conference (March 28th) has begun with a "Summer Olympics" theme.

c. Academic Update

- C. McClelland restated the school's 2023-24 academic standing and goals.
- The pathways to removing the school's CSI designation were outlined
- C. McClelland also shared the results of the Q2 formal assessments and academic progress.
