#### WHY ARE WE HERE?

The Every Student Succeeds Act (ESSA) requires that each Title I school hold and annual meeting for Title I families in order to:

- inform you or your school's participation in Title I.
- explain the requirements of Title I, and

#### WHAT IS A TITLE I SCHOOL?

- Title I was passed in 1965 under the Elementary and Secondary Education Act (ESEA). It is the largest federal assistance program for our nation's schools.
- Title I schools receive extra funding (Title I dollars) from the federal government.
   These dollars are used to:
  - Identify students experiencing academic difficulties and provide assistance to help these students;
  - Purchase additional staff, programs, materials, and/or supplies; and
  - Conduct parent and family engagement meetings, trainings, events, and/or activities.

#### WE ARE A TITLE I SCHOOL

- The Soulsville Charter School is a federally funded school-wide Title I school.
- Title 1 requires that schools promote a positive and supportive learning environment that results in high levels of achievement for all students.
- Title I funds are available for academic programs and strategies, additional teachers and other personnel, staff development, materials, supplies, technology, and parent involvement and training.
- We look forward to working with you and your child to make this a rewarding 2025 2026 school year.

## WE ARE A TITLE I SCHOOL (CONT.)

#### Elementary and Secondary Education Act (ESEA) Parents' Right-To-Know

#### All parents have the right to request the following:

- A teacher's professional qualifications, which include: state qualifications, licensure, grade/s certification, waivers,
- A teacher's baccalaureate and/or graduate degree, fields of endorsement, previous teaching experience,
- A paraprofessional's qualifications, and
- An assurance that their child's name, address, and telephone listing are not released to military recruiters

## WE ARE A TITLE I SCHOOL (CONT.)

#### All parents will receive information on the following:

- Their child's level of achievement in each of the State academic assessments.
- Their right to public school choice, supplemental services, and more effective involvement if their child's school is identified for school improvement.
- Their option to request a transfer to another school within the district if their child is the victim of a violent crime at school.
- Their right to timely notification that their child has been assigned, or has been taught for four or more consecutive weeks by, a teacher who is not highly qualified.

## WE ARE A TITLE I SCHOOL (CONT.)

#### All parents will receive information on the following:

- Their child's level of achievement in each of the State academic assessments.
- Their right to public school choice, supplemental services, and more effective involvement if their child's school is identified for school improvement.
- Their option to request a transfer to another school within the district if their child is the victim of a violent crime at school.
- Their right to timely notification that their child has been assigned, or has been taught for four or more consecutive weeks by, a teacher who is not highly qualified.

### WHAT IS THE SIP?

- The SIP is the School Improvement Plan. It includes:
  - the identification of the school planning team and how they will be engaged in the planning process;
  - a needs assessment and summary of academic and non-academic data;
  - prioritized goals, strategies, and action steps to help address the academic and non-academic needs of students;
  - teacher and staff professional development needs; and
  - budgets and the coordination of resources.
- The school must include family representatives on our school planning team.

#### **HOW PARENT & FAMILY ENGAGEMENT FUNDED?**

- Any district with a Title I allocation exceeding \$500,000 is required by law to set aside 1% of it's Title I allocation for parent and family engagement.
- Of the 1%, 10% may be reserved at the district for system-wide initiatives related to parent and family engagement. The remaining 90% must be allocated to all Title I schools in the district.
- You, as Title I parents and family members, have the right to be involved in how this money is spent.

# WHAT IS A PARENT & FAMILY ENGAGEMENT POLICY?

These plans address how the district and school will implement the parent and family engagement requirements of ESSA. Components should include:

- how parents and families can be involved in decision making and activities;
- how parent and family member engagement funds are being used;
- how information and training will be provided to families; and
- how the school will build capacity in families and staff for strong parent and family engagement.

You, as a Title I parent or family member, have the right to be involved in the development of these plans.

#### WHAT IS A SCHOOL-PARENT COMPACT?

- A school-parent compact (Commitment to Excellence) is a written commitment that outlines how the entire school community, teachers, families, and students will share the responsibility for improved academic achievement.
  - The compact describe how the school will:
  - o provide high-quality curriculum and instruction;
  - hold parent-teacher conferences, annually in elementary schools;
  - provide parents with reports on their child's progress;
  - provide parents reasonable access to self.
  - provide parents opportunities to volunteer; and
  - ensure regular two-way meaningful communication between family members and staff, to the extent practicable, in a large family members can understand
- You, as a Title I parent or family member, have the right to be involved in the development of the compact.

# COMMITMENT TO EXCELLENCE AGREEMENT and TRUANCY

#### PARENTS'/GUARDIANS' COMMITMENT:

We will make sure our child arrives at school prepared to learn every day and be seated in Community Base (CB) by 7:40 a.m. (Monday-Friday).

#### **Truancy**

- According to MSCS: Truancy is 5 unexcused absences. Under the "compulsory education" laws, children must regularly attend school from the time they are 6 years old until they turn 18.
- The MSCS "District" will intervene if a Student receives additional absences after the TSCS sends a warning notice. District Intervention means a referral to Juvenile Court, which may result in fees and/or other drastic measures.

### School Attendance: It's The LAW

#### The Soulsville Charter School:

- Has to follow the rules and guidelines of Truancy which includes warning letter,
   mandatory attendance meetings, etc.
- Can "disinvite" The Student/Family because of failure to adhere to the policy of Commitment of Excellence Parent agreement (Beginning on page 39 in Student Handbook)
- Will log/document 5 tardies as 1 unexcused absence
- Attendance documented attempts to Student's Families to comply in PowerSchool
- Chronic Absenteeism vs Truancy
- Unexcused vs Excused Absences



#### **MILITARY INFORMATION**

Federal law requires schools that receive federal aid to give military recruiters the names, addresses, and phone numbers of high school juniors and seniors, and to provide military recruiters with the same access to students as employers and college recruiters. Any parent or guardian wanting this information withheld from the military must make objection, in writing, within two weeks of receiving this notice, to the main office. (Please use the attached form to make your request.) If this is your preference, a request must be made on a yearly basis and should specifically indicate withholding from the military only.

State Mandated (RTI2): Universal Screener	July 30, 2025 - August 1, 2025	Students in 6th Grade will complete the reading and math i-Ready Diagnostics during 6th grade orientation.
State Mandated (RTI2): Universal Screener*	August 5, 2025 - August 15, 2025	Students in grades 7-12 will complete the reading and math i-Ready Diagnostics.
Mock ACT #1	September 9, 2025	All students in grades 10th - 12th will participate in a predictive ACT assessment to support students progress towards college and career readiness.
SSIA (Soulsville Scholar Interim Assessment)	October 6, 2025 - October 10, 2025	Grades 6-8 and HS students enrolled in EOC- tested courses will take standards-based assessments in ELA, math, social studies, and science.

# State Testing

As you've probably seen, 2024-25 TVAAS data, value added data, has been released to the public. The Tennessee Value-Added Assessment System (TVAAS) measures student growth year over year, regardless of whether the student is proficient on the state assessment. In calculating a TVAAS score, a student's performance is compared relative to the performance of his or her peers who have performed similarly on past assessments.




